Vagher also stated that he did check with JR Auto out of Garden City, and the price of a 2022 Dodge Durango is approximately \$40,000.00.

City Clerk Britton stated that she spoke with Mary Carson with Triplett, Woolf, Garretson, about bonding the underground waterline along U.S. Highway 160, and installing a water tower control system . Britton stated that Mary sent her 3 different debt schedules this morning, but she did not have time to review them, so she asked if we could review them at the next meeting.
