## Condemnation 300 S Joyce

City Administrator Olson stated the owner, Pete Woods is here to speak in regards to the condemnation at his property at 300 S Joyce. Pete explained to the council that his plan is to bring in a new house shortly after the first of the year.

Mayor Battin explained to Pete that the problem at hand is that his property is a public hazard, because anybody could fall in the basement.

Council Member Warner asked Pete what can you do to make this property safe immediately until you are able to put in a new home.

Home owner Pete Woods stated that he could put up a fence around the property, and put plywood to cover the holes in the floor of the house.

Mayor Battin stated that there needs to be a six foot fence around the property, and cover the holes in the floor to make it safe.

City Attorney Dave Black stated the city will have to publish the findings from tonight's hearing in the paper, and Pete will have until November 6, 2019 to have it completed.

Council Member Deckert asked Pete Woods what his plan is for the green house. Pete stated that he plans on covering it with plastic.

Council Member Warner stated that the city will deal with the green house if the house project is not completed in a timely manner.

Motion by Council Member Warner, seconded by Council Member Deckert stating that the property at 300 S Joyce is unlivable at this time, and the owner needs to make the property safe by putting up a 6 foot fence and covering all the holes in the floor. This must completed by November 6, 2019 at 5:00p.m. or the city will take action, and make the property safe. Council Members Velasquez, Duran, McCauley and Guy, voted yea. Those voting nay, none. Motion carried, 6 yeas. Nays, none.

# Ordinance 1285 Rezoning the 11.3 Acres Connected to 1407 E Oklahoma
