### **Resolution 19-4**

City Administrator Olson explained that resolution 19-3 needed to be published two consecutive weeks in the Ulysses news, and that did not happen so under the advice of the city attorney Black the process must start over. Olson stated that resolution 19-4 must be voted on.

### Community Mexican Independence Festival Shayla Jaquez

Citizen Shayla Jaquez explained how the festival has come about, and all the events that will be offered during the festival. Shayla also stated they are asking for donations from local businesses to help fund this event. The festival will be September 14, 2019 from 12:00 to 9:00p.m.

Mayor Battin stated for Shayla to get with City Administrator Olson to work out the details for the event.

### **Safety Incentive Program Amendment**

City Administrator Olson stated that the city safety committee has proposed a new Safety Incentive Program.

Some of the changes include:

- 1. It is mandatory for all City of Ulysses Employees, not including the employees of Ulysses Police Department, to attend at least six safety meetings a year. If an employee does not complete the mandatory safety training for the quarter, he/she will not be eligible to receive the safety incentive for that quarter.
- 2. Damage to equipment or property is considered cost to the City of Ulysses in the amount of \$1,000.00 or more. Any damage to equipment or property will be considered at the discretion of City Department Heads and Administration.
- 3. For each City of Ulysses department without a lost-time accident and without an accident causing damage to equipment or property on a calendar quarterly basis, each eligible employee will receive \$50 in Ulysses Bucks.
- 4. If all City of Ulysses employees complete one year without a lost-time accident and without an accident causing damage to equipment or property, every eligible employee will receive \$150 in Ulysses Bucks.

Motion by Council Member Warner, seconded by Council Member Duran to approve the amended Safety Incentive Program. Council Members McCauley, Deckert and Guy, voted yea. Those voting nay, none. Motion carried, 5 yeas. Nays, none.

### **Quarterly Report**

City Administrator Olson stated he received a phone call from Mrs. Wickwar, and she is asking what the city might be able to do for the all school reunion in May 2020. During the conversation half price green fees at the golf were mentioned during the days of the event.

Council Member Warner suggested that the council table this issue so we can prepare a proposal that will explain how this event will work every five years.

City Administrator Olson stated what if we do half price green fees every memorial weekend each year.

Motion by Council Member Warner, seconded by Council Member Deckert to table the all school reunion request. Council Members McCauley, Duran and Guy, voted yea. Those voting nay, none. Motion carried, 5 yeas. Nays, none.

City Administrator Olson stated that another water well was struck by lightning. Olson also stated that yesterday he had a meeting regarding rebuilding green number 7 at the golf course.

#### **COUNCIL MEMBER'S COMMENTS**
