Erica Oglevie Rotary

Erica Oglevie with Rotary stated that the Ulysses Rotary Club is trying to get a Grant through the Rotary district to work on projects throughout the community. The Ulysses Rotary Club is wanting to put in a public water fountain at the end of the Patterson sidewalk. Erica stated that Rotary is willing to pay for the water line, water meter, the instillation of the fountain, pay for the water on a annual basis, and any maintenance on the fountain. Erica is asking permission on behalf of Rotary to put the water fountain on the city's property.

Golf Course Equipment Purchase
