## **Roof Bid AA Building**

## **City Hall Remodel**

City Administrator Olson stated the city has received an estimate for carpet from J&M Paint out of Garden City, and explained to the council that we do not have other estimates because contractor

Craig Malone is associated with J&M, so therefore the city will receive the carpet at a discounted rate.

Olson also explained that there will be a recurring service of \$77.90 a month for access control to the cloud and any maintenance needed.
