### **Quarterly Report**

Interim City Administrator Olson stated we started 2018 with \$6,797,270.70 cash on hand, and the ending balance for the first quarter is \$7,442,632.06. Olson also stated that the sales tax this year is up approximately \$20,000.00 from this time last year.

#### **STAFF COMMENTS**

City Clerk Britton stated that council member John Duran will be taking her place on the Tigers In Action Board.

Interim City Administrator Olson stated that he sent the council a copy of the ordinances for fishing at Frazier Lake. Olson asked the council that if they see any changes that need to be made to contact him before the next meeting, because he would like to pass them by the next meeting. Olson also stated that he has received some educational information from the fishing and game department that he would like to get out to the schools, so the younger kids will have an understanding of the procedures of catch and release fishing.

Interim City Administrator Olson stated that the Hickok School had a walk a thon that raised \$6,600.00 dollars in donations for the animal shelter. Olson suggested that we need to do something to thank Hickok school for the donation.

#### **COUNCIL MEMBER'S COMMENTS**

Council Member Deckert stated that she is in favor of stopping the opioid crisis, but this might become a burden for the city and county, because of the costs of reversing drugs for the opioid addictions.

Council Member Guy stated that the city crew did a great job removing the items in the alleys for Spring Clean Up.

Mayor Battin stated that he would like the council members to ride with a Police Officer, City Inspector Richard Banes, or come into city hall to see what each of these jobs entails each day. Battin also stated that he would like a council member present at each Golf Board Meeting so the council can be informed of what is going on. Battin stated to the council if we are more involved we will be more informed of what is going on in the city.
