

UPDATED CONTRACTOR LICENSE APPLICATION INFORMATION

November 30, 2022

We hope that 2022 was a successful year for you. If you plan to renew your Contractor License for 2023, please read the information that is being provided below. As we welcome a new year, our department will be undergoing many new changes going forward. We are currently in the administrative process of adopting the 2018 Building Codes. This also brings changes to requirements listed in Chapter IV of Ulysses City Code. Upcoming changes that will be implemented once Ulysses City Code amendments have been adopted will include but not be limited to the following:

- License and permit fees
- Proof of passing Kansas or National exam pertaining to specific license request with a minimum score of 75% for <u>all trades</u>, including commercial roofers.
- Continuing Education Hours for anyone that passed their exam at least one (1) year prior to applying for a City of Ulysses License.
- Trades which are grandfathered
- Revised license application process
- Revised requirements for obtaining building permits
- Letter of good standing from the State of Kansas
- List of employees authorized to obtain permits (if) other than the business owner

Contractors will be notified once amendments to Chapter IV of the Ulysses City Code have been adopted. Once adopted, all contractors who have not renewed their license or those applying for a new license will be required to meet the new standards implemented. The intent of the code regulations is to establish a comprehensive set of codes and standards, designed to be compatible with one another, which will provide for better building construction and greater safety to the public.
