STAFF COMMENTS

The second one being on page 45 Section 8 Number 1 an accessory buildings square footage footprint may not exceed the footprint of the principal dwelling, excluding attached garages.

City Administrator Olson stated that City Inspector Richard Banes will be retiring on February 4, 2022, and that the city has advertised for this position. Olson also stated that the utility bills have been sent out late due to some computer issues, so if you get a questions regarding the billing we are trying to get things back in order.

City Administrator Olson stated that most of the city water department is out due to Covid. Olson also stated that the city has received the Coronavirus State Local Fiscal Recovery Funds (SLFRF) Final Rule.
