Letter written to the council from citizen Jesus Garay Munoz: I am the owner of the lot located at 838 S Court St in Ulysses. The reason I am writing this letter is because last year Yadira Ibave moved her mobile home from Hays KS, to Ulysses, before she moved the trailer I went to the Ulysses City Hall to ask about the necessary requirements that the city requires. The inspector Richard was not in the office, so they gave me his telephone number and I contacted him and specified the year of Mrs. Yadira Ibave's mobile home, and he told me that he was fine with it as long as the mobile home had gas lines made of black iron, that the mobile home was in good condition, that the siding is in good condition, the sewer lines are connected, water is connected, and electricity is connected. I spoke with Mrs. Yadira and she told me she was trying to install the skirting of the mobile home, but could not find someone to do the job. She also told me that she went to get the permit but she did not know, and she went to the Grant County Courthouse instead of going to the city hall, as you can see she tried to do everything according to the city. I would like to be given the opportunity to move the trailer since everything is very expensive due to inflation and there is no place or land to put the trailer. I hope you understand the situation in which Mrs. Yadira Ibave is. As I already specified before, the trailer is in very good condition, and I have spoken with her and she is willing to make arrangements if necessary, I thank you for your time and I hope you understand us and give Mrs. Yadira the opportunity to be able to keep the mobile home on my property.

Mobile home owner Yadira Ibave asked the council is she would be able to leave her trailer on this property, because she has been trying to work on it.

City Inspector Anguiano stated the trailer was in violation first for not having skirting, and then after calling the appraisers office and finding out that the year of the trailer it is also in violation for being older than ???, and is out of compliance and needs to be moved off the property.

Mayor McCauley and the council is in agreement that the trailer is out of compliance and, the ordinance states that the trailer needs to be moved in 45 days.

Pete also stated if there's more work, we may have success in getting a contractor to come to Ulysses.

Pete stated that that the city will receive \$1.0M for the first phase, and \$1.5M for the second phase for a total of \$2.5M for the 160 Highway Project.
