CONSENT AGENDA

Motion by Council Member Duran, seconded by Council Member Guy to approve the consent agenda. Council Members Warner, Woods, Maas, and Diaz, voted yea. Those voting nay, none. Motion carried, 6 yeas. Nays, none

Visitors:

Sarah Loewen with Ulysses News asked the council if they would like to put an ad in the Experience Grant County Magazine. Sarah stated that the City of Ulysses purchased a half page ad last year, and asked if they would like to do the same this year. The council was in agreement to purchase the ad.

OLD BUSINESS

Pete Woods 300 S Joyce

Property owner Pete Woods asked the council for more time to get his property in compliance. Pete stated that he could have a six foot chain link fence put up by August 1st, and building plans to build a house on the property. Pete also stated that his plan is to build a home, and sell the property.

Council discussed the issues with this property, and the concerns that they have for the safety of the public.

City Administrator Olson stated that their appears to be two issues with this property. The first one being the condition of the property, and making it safe, and the second one is will there be a building permit issued at some point. Olson stated that the first issue is the most urgent to deal with in his opinion, which is the weeds and the safety of the property.

Olson stated that a time needs to be given when the first issue will be completed, and if not completed what is the city going to do to make it safe.

Motion by Council Member Warner, seconded by Council Member Maas First: that at the property at 300 S Joyce there needs to be a safe fence constructed, and the weeds brought into compliance by August 1, 2022, and if not completed on the morning of August 2, 2022 the city will make the property safe by the expense of the property owner. Second: That by August 15, 2022 the property owner will need to have a signed building contract, by the owner and constructor. In the contract a starting and ending date will need to be defined. The owner and contractor need to be present at the special meeting on August 15, 2022 at 5:00p.m. If not completed on August 16, 2022 the city will proceed with the condemnation process at the property owners expense. Council Members Diaz, Woods, Guy, and Duran, voted yea. Those voting nay, none. Motion carried, 6 yeas. Nays, none.

NEW BUSINESS

Energy Fuel Cost Mitigation Fund

City Administrator Olson stated this is a fund that would be used for unknown energy and fuel costs. Olson explained that this fund would help budget for unexpected costs, and if the funds are not needed it would be able to be used for something else.

Fuel Cost Mitigation Fund

Subject: Creation of Energy Fuel Volatility Mitigation Fund

Action: Move 5% of the proceeds of city sales tax to a fund to be primarily used to mitigate long and short term energy and fuel price fluctuation.

Explanation: Volatile markets in energy and fuel prices have made it difficult for departments to realistically budget for rate hikes. This fund would help ensure energy fuel costs are covered with less potential negative impact on city budgets.

Motion by Council Member Woods, seconded by Council Member Warner to approve the Energy Fuel Cost Mitigation Fund. Council Members Guy, Duran, Maas, and Diaz, voted yea. Those voting nay, none. Motion carried, 6 yeas. Nays, none

City Administrator Olson reminded the council about the Special Meeting on July 14, 2022.

Council Member Diaz stated that the County Fair is next week, and we just need to remind the city officers of the extra traffic on Patterson.
