#### Humane Society

Mary Eves and Joyce Adams with the Garden City Humane Society spoke with the council about what it would take for the community to start a Humane Society in Ulysses.

## Benefits:

- 1. Takes responsibility off Law Enforcement for complete running of the shelter.
- 2. Gain additional funding.
- 3. Gets whole community involved for the greater good of the city.

## **Recommendations:**

- 1. Have the initial group meet and decide on one or two people to take the lead. As a group either decide on a name or put it to the public and have a contest.
- 2. Once the name is chosen, start the 501 C3 process. Check with the Secretary of State to see if your name is a new one. Once the 501 C3 is completed, this will give the organization a non profit status and the grant writing can begin. Any money donated at this point is a tax deduction. Look at setting up a trust.
- 3. Have the city and county put in the budget for next year a additional person to run the shelter, possibly write grants, clean and feed animals, handle adoptions, find rescues and transports, and develop a medical fund for injured and ill animals.
- 4. Get local veterinarian on board or traveling veterinarian with a Mobil Unit and hold spay and neuter clinics plus vaccination.
- 5. Organize volunteers from all walk of life. Some can just donate money, others can help with clinics, help with cleaning the shelter, be an organizer for events or just general worker bees!

We are available just call or we will come over if possible. We can help facilitate training for your shelter. We invite those interested to visit our shelter as well.

## Ordinance 1301 Storm Water Fee

City Administrator Olson stated this is an ordinance regarding the monthly storm water fee per water meter, and will also be raised by 1%. This ordinance shall take effect on all billing on and after January 1, 2022.

## Ordinance 1302 Wastewater Collection

City Administrator Olson stated this is an ordinance regarding wastewater collection and treatment system, all users of the Ulysses wastewater collection and treatment system shall be charged a user fee that shall be billed monthly, and will also be raised by 1%. This ordinance shall take effect on all billing on and after January 1, 2021.
